

c. Westport assigned all of its rights, title, and interest in the two parcels to Grossmont Medical Center Partners ("GMC") on August 7, 1984. GMC assigned all of its rights, title, and interest in the two parcels to First Interstate Mortgage Company ("First Interstate") pursuant to a certain Trustee Deed recorded November 22, 1989. First Interstate assigned all of its rights, title, and interest to GMA Grossmont Medical Arts, Ltd. ("Medical Arts") on June 28, 1990. Subsequently, on June 28, 1990, Medical Arts granted Thomas and Associates, an 80.25% undivided interest in and to the two parcels. Thomas and Associates assigned such interest to the La Briola Family Trust pursuant to a Quit Claim Deed recorded March 18, 1991 as Instrument No. 1991-0118781 in the Official Records of San Diego County, California and subsequently to J. Harold La Briola and Edna La Briola, Co-Trustees of the La Briola Family Trust dated May 1, 1992 (the "Trust") pursuant to a Correction Deed recorded August 25, 1994 as Instrument No. 1994-0512506 in the Official Records of San Diego County, California. The Trust transferred such interest to Medical Arts pursuant to that certain Partnership Quit Claim Deed recorded March 26, 1996 as

- A. On May 29, 1991, Landlord and Tenant entered into that certain Lease Agreement (the "Lease") whereby Landlord leased to Tenant for a period of thirty (30) years that certain real property described in Exhibit "A" to the Lease (the "Described Property").
- B. Included in the Described Property were two parcels of land (the "Two Parcels") of which the Landlord had previously leased pursuant to that certain Ground Lease First Parcel dated June 19, 1984 (the "Ground Lease") between Landlord and Westport Centers, Inc. ("Westport").

This Amendment to Lease (the "Amendment") is entered into on this 17th day of May, 1996, between GROSSMONT HOSPITAL DISTRICT, a political subdivision of the state of California, organized and existing pursuant to the Local Hospital District Law (Division 23 of the California Health and Safety Code) ("Landlord"), and GROSSMONT HOSPITAL CORPORATION, a California nonprofit public benefit corporation ("Tenant").


