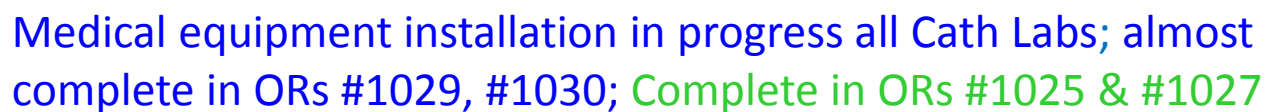
2. H&V Level 1 Surgery Build Out

- Medical equipment installation complete in ORs #1025 & #1027; in progress in ORs #1029 & #1030; and all Cath Labs
- AE formal punch list of the ORs and Cath Labs complete
- Schedule delays: 65 days approved to date; advised that due to Philips medical equipment installation delays there may be an additional 13 day delay to 6-13-18
- Test & Balance of HVAC system underway
- Commissioning of the medical equipment system underway
- Commissioning of the electrical, HVAC systems to start early May

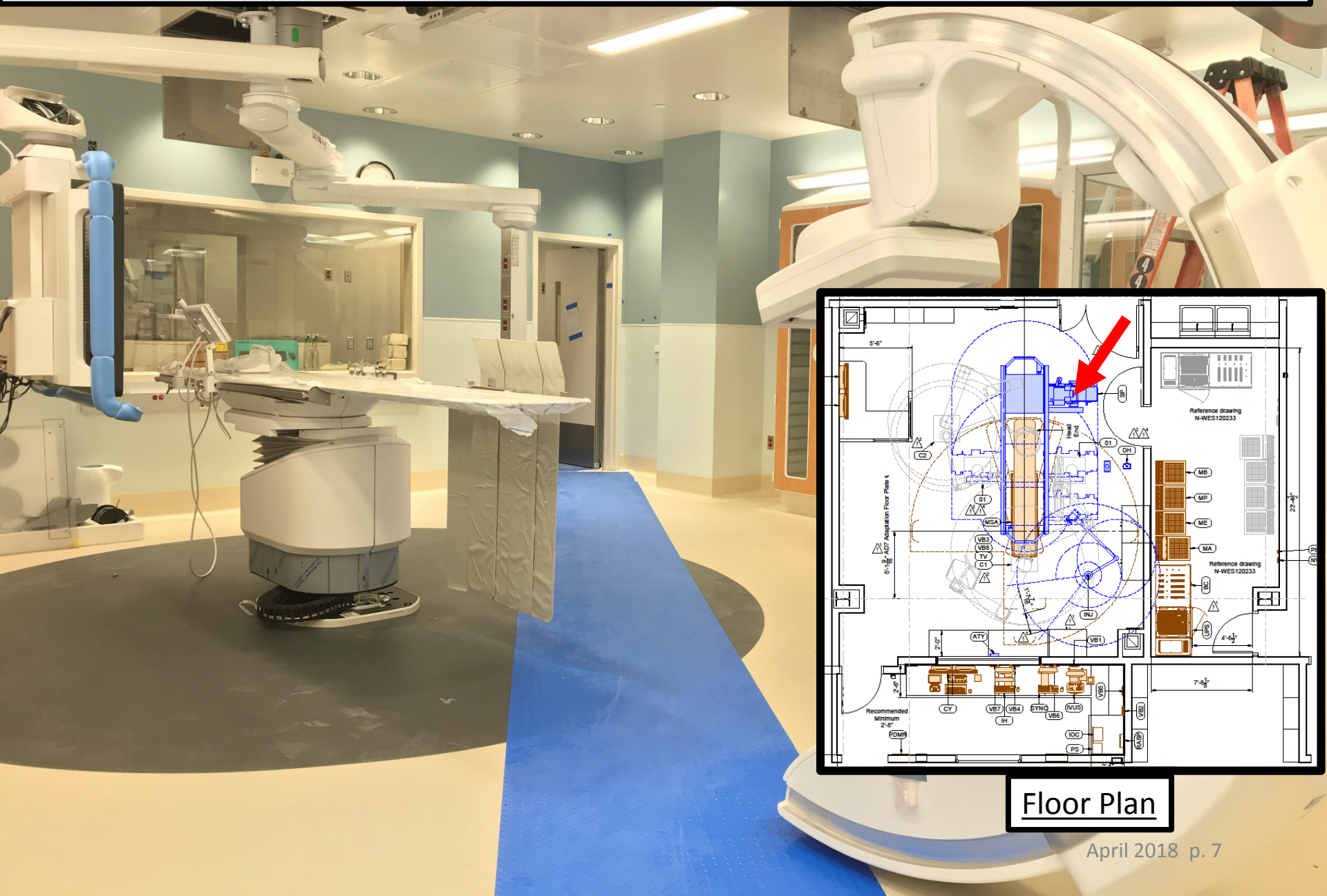


Southwest Corridor: T-Bar grid, wall protection, flooring, fire alarm devices installed




3ii. Equipment Install Cath Lab #1023:



Floor Plan

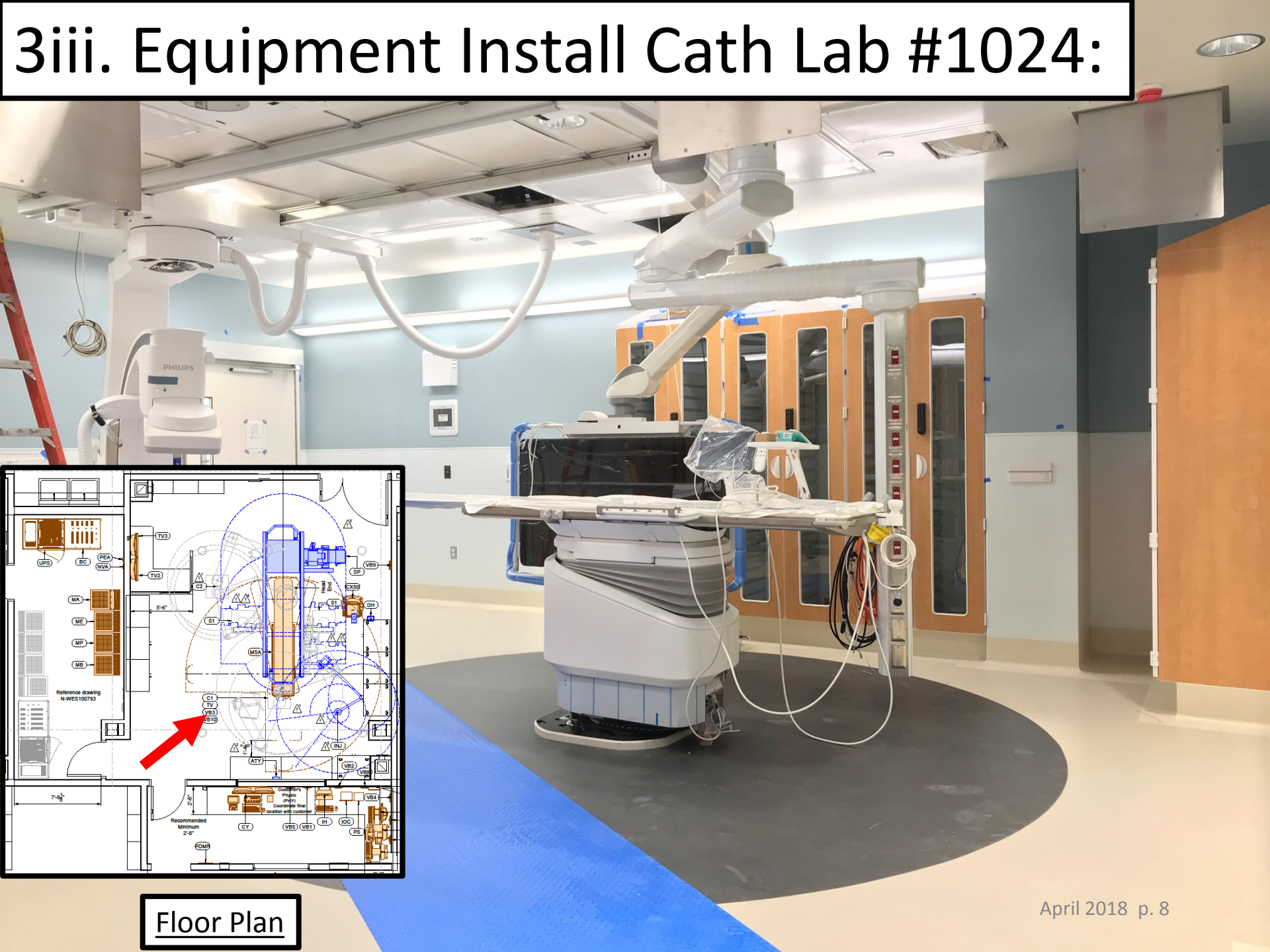

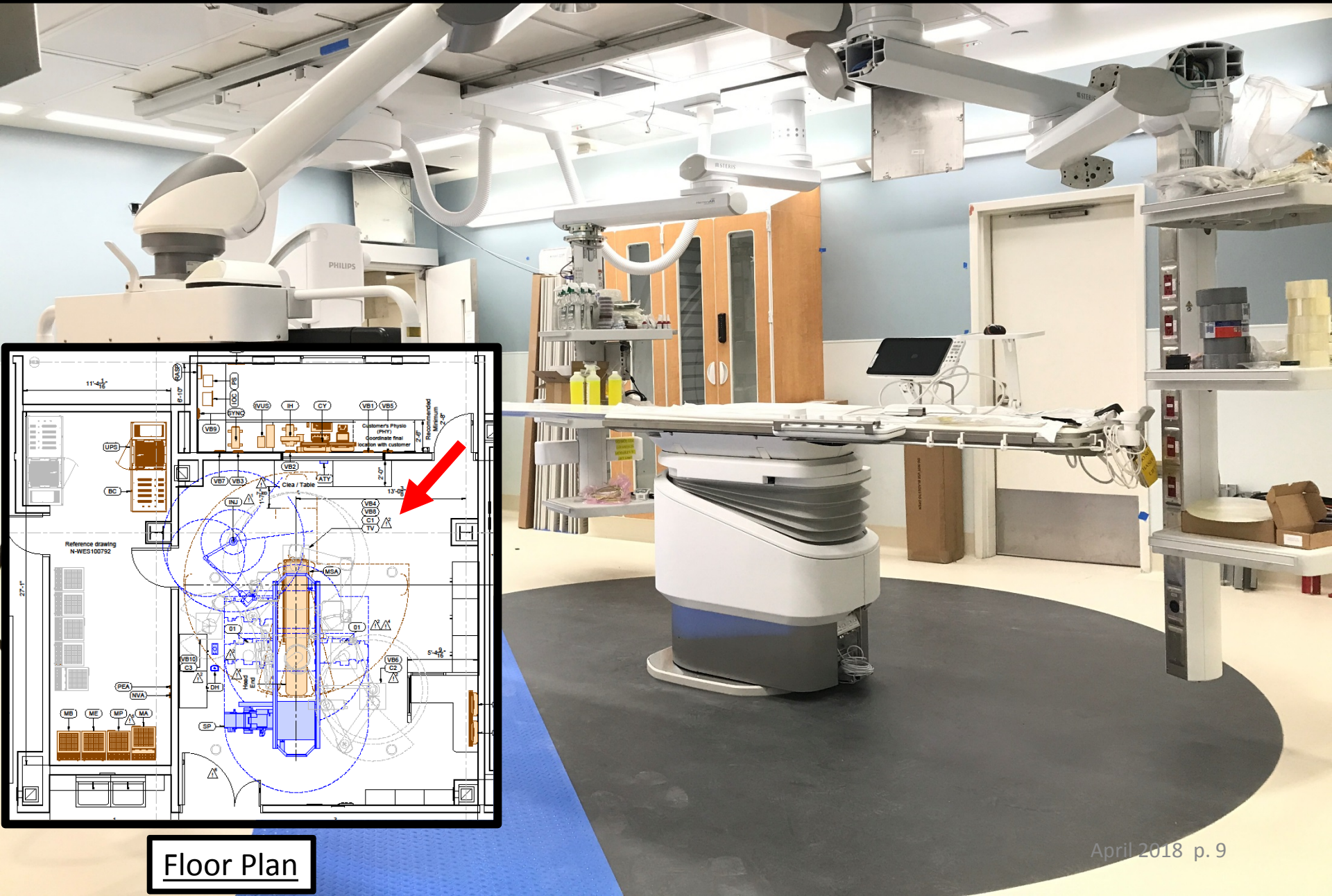

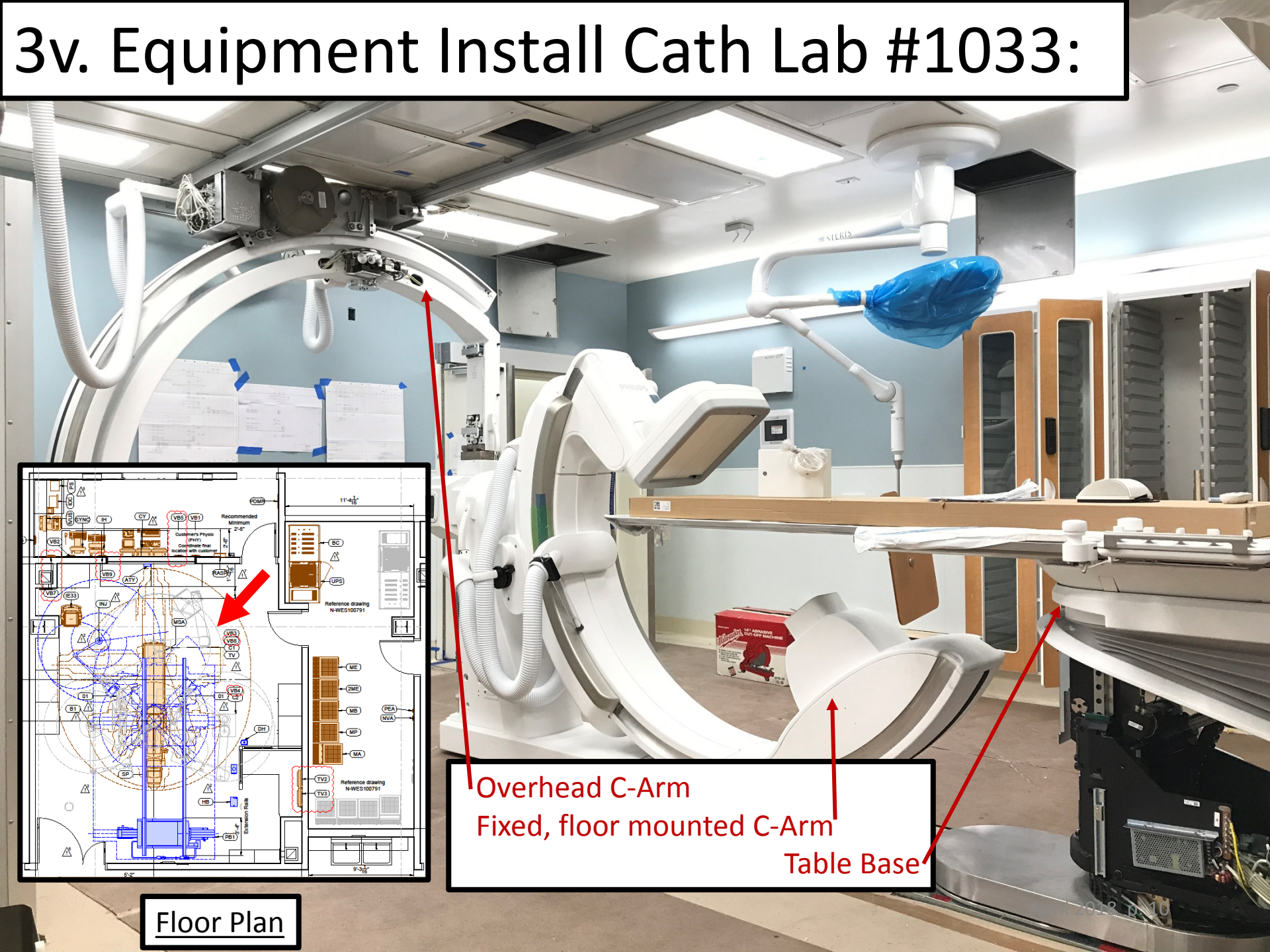

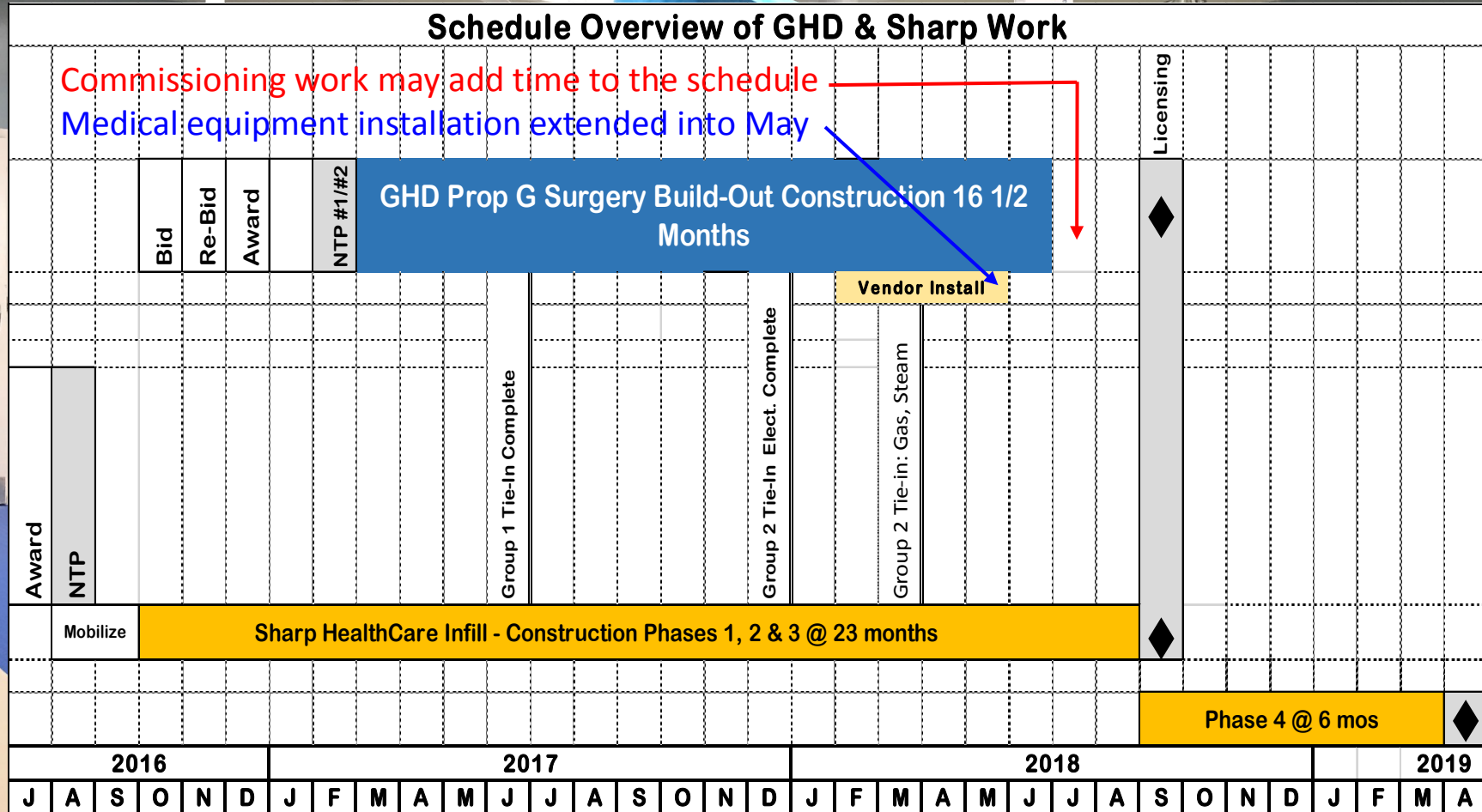

- Complete installation of casework, plumbing fixtures, solid surface tops
- Complete installation of flooring, corner guards, wall protection in new Phase 2 area
- Complete installation of overhead devices & system
- OSHPD approval for Phase 2 issued 4/11/18
- Phase 3 underway

7. Looking Ahead



- Complete Test & Balance on HVAC, electrical, medical equipment systems
- Complete Functional Performance Testing of essential systems
- Start 3rd party commissioning of HVAC, electrical systems
- Work with Helix Water District to finalize an agreement wherein they will self-perform the installation of approximately 65 lineal feet of new water line
- Complete installation of medical equipment in Cath Labs #1023, #1024 #1032, #1033 (projected into mid-May); ORs #1029, #1030
- Complete construction completion (Punch) lists
